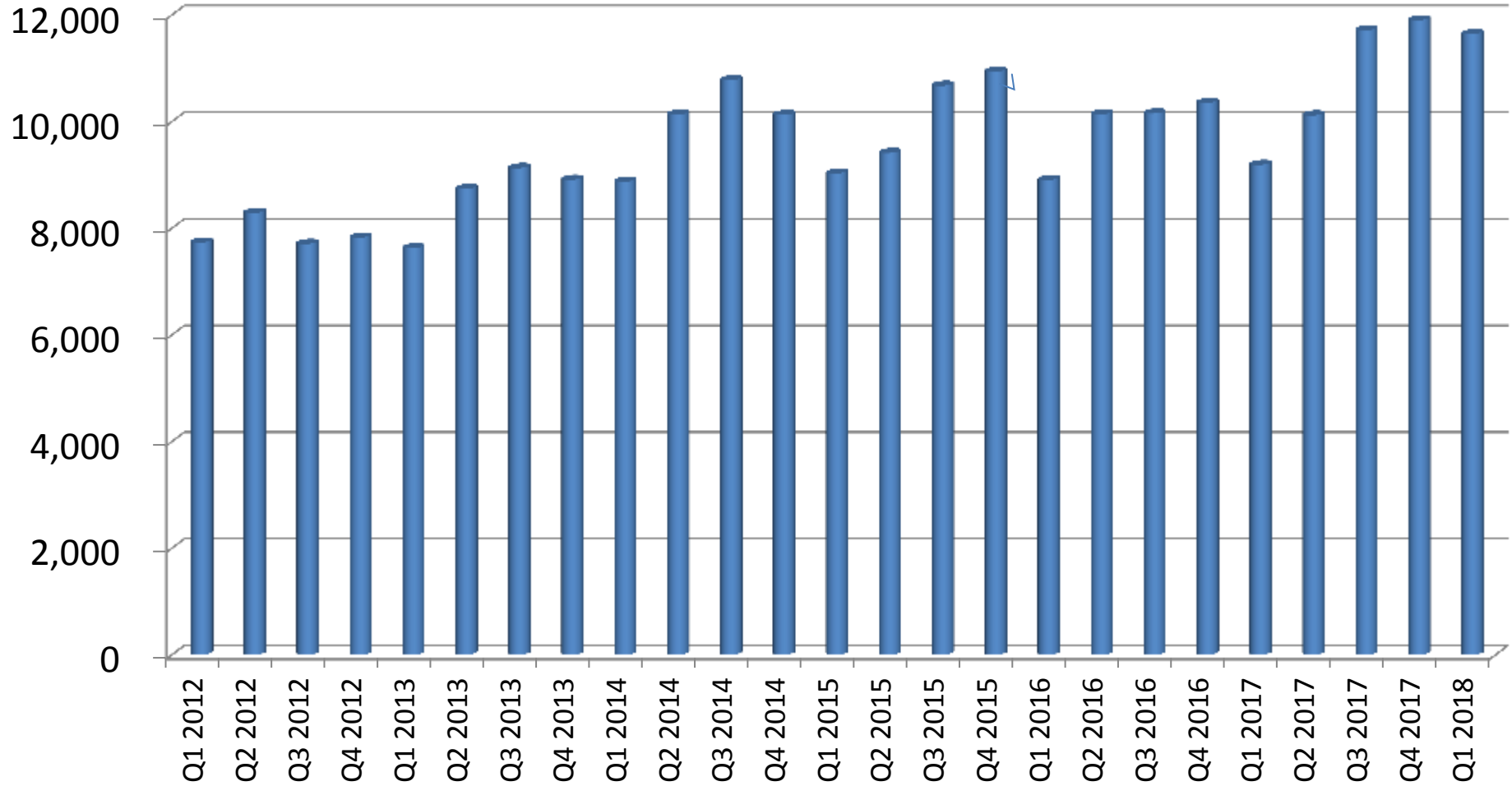

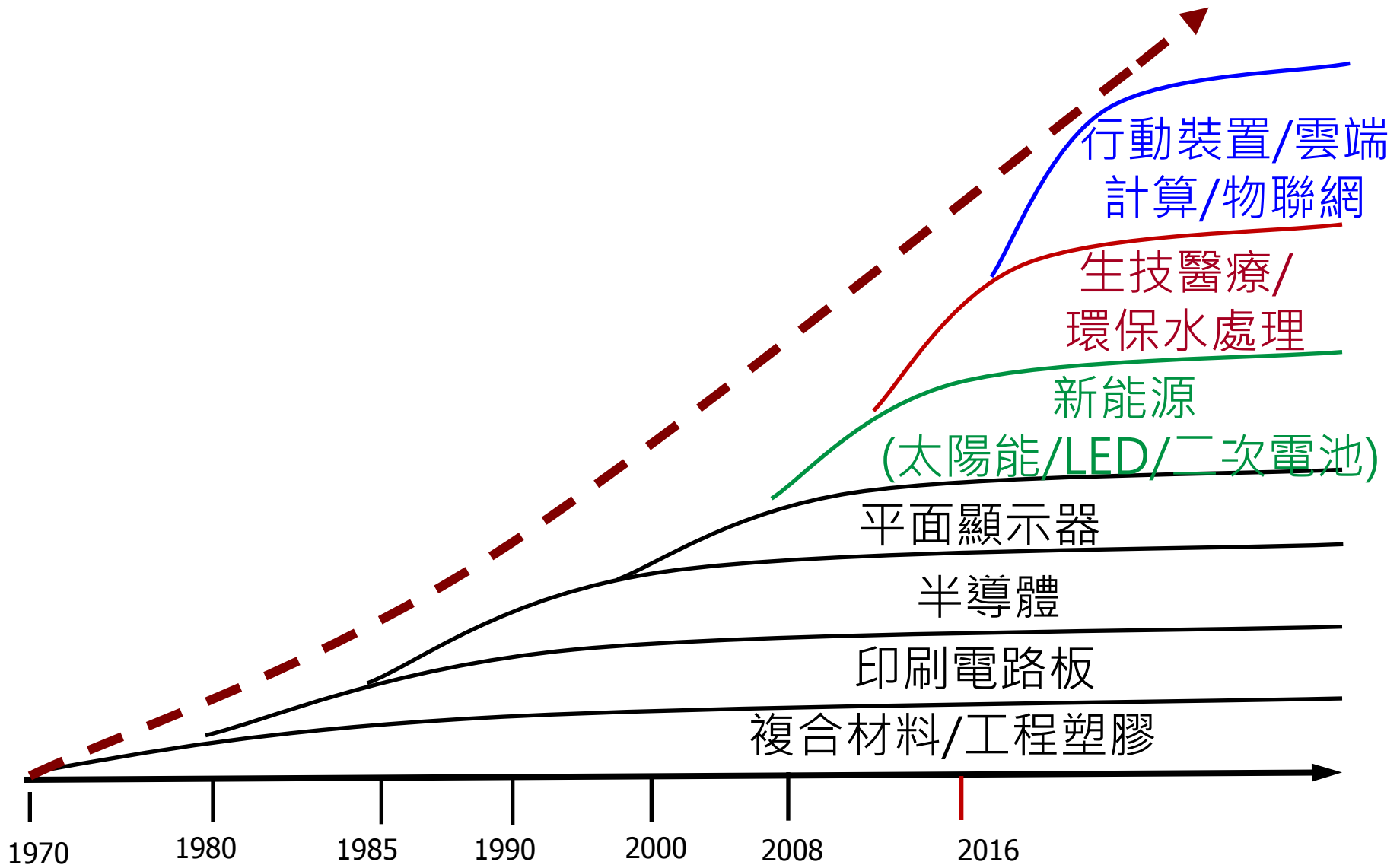

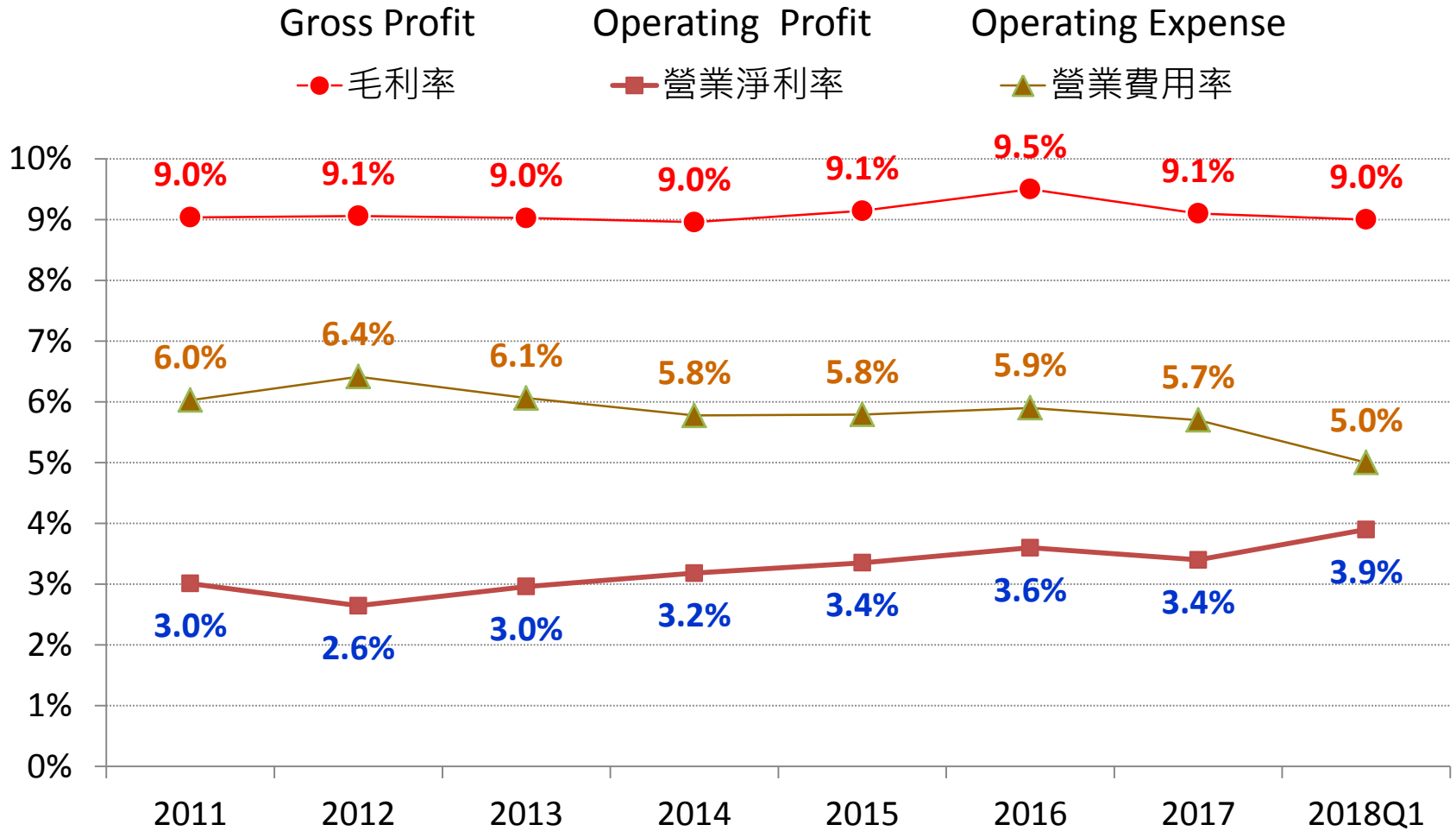
Cap Ex and Return on Fix Asset 資本支出及固定資產效率

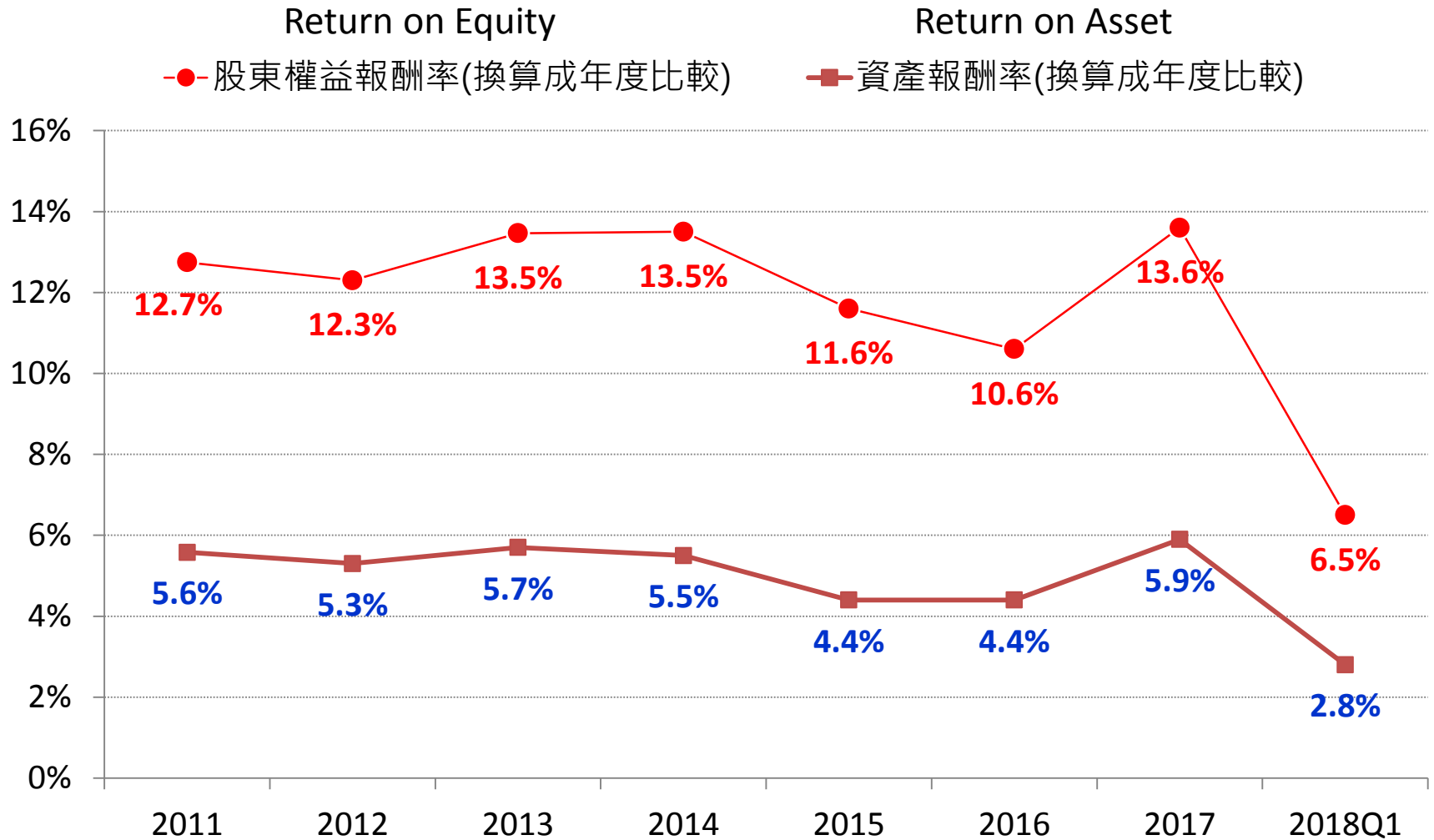


Key Profitability Indicator 獲利能力財務比率

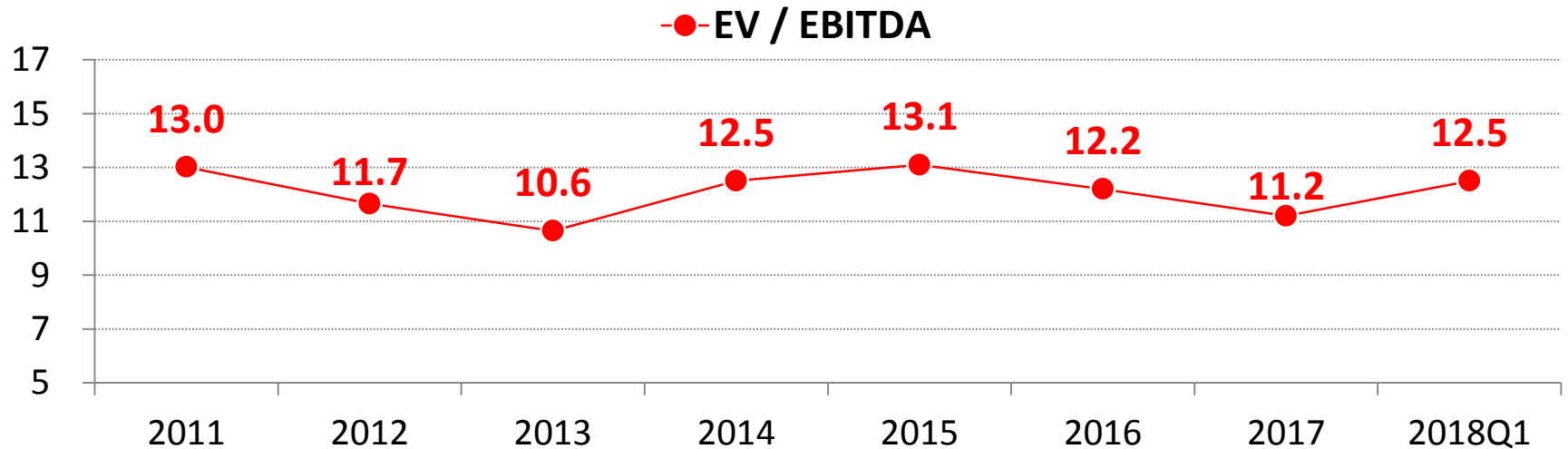


Key Returns Indicator 報酬率
