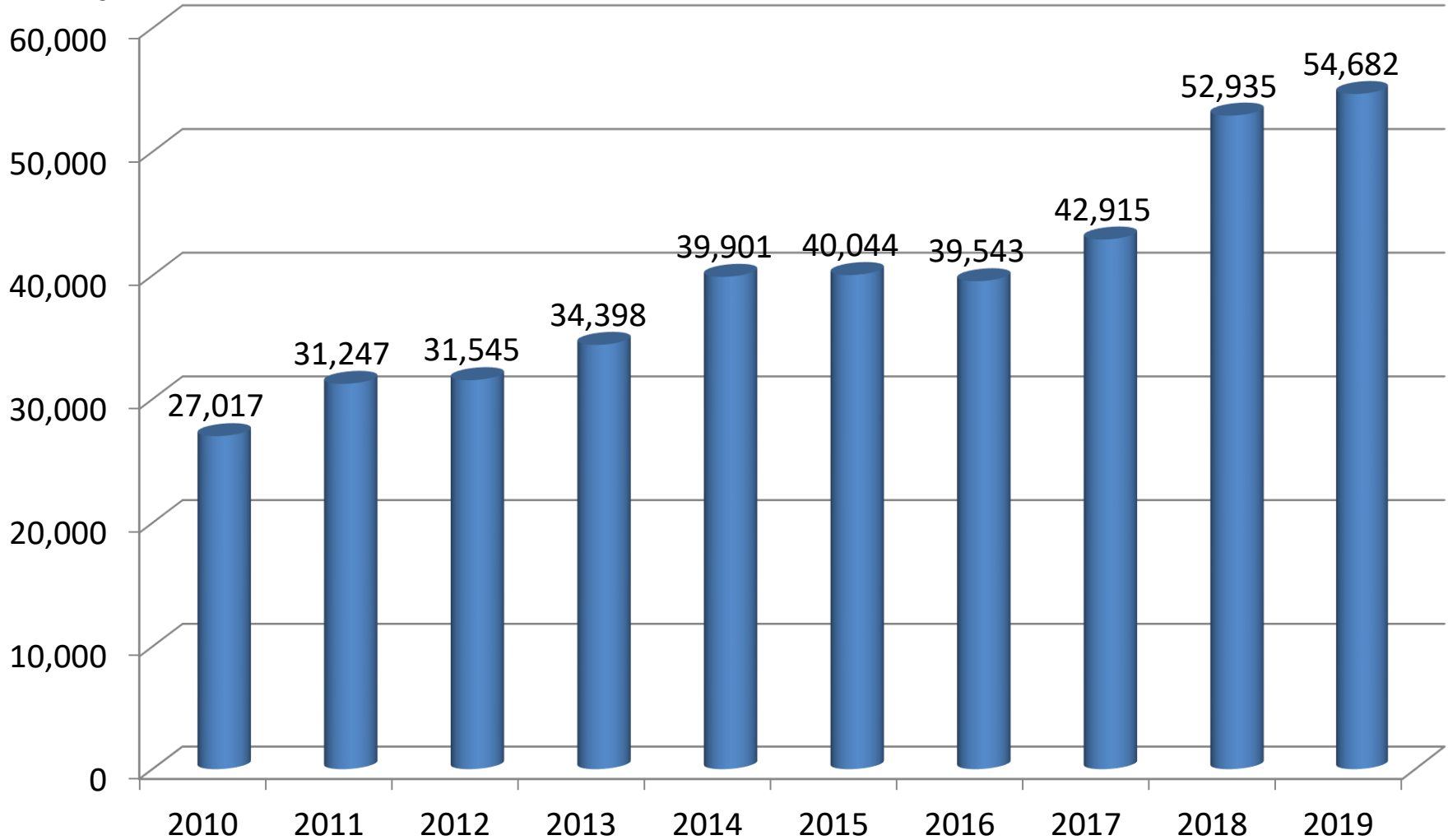

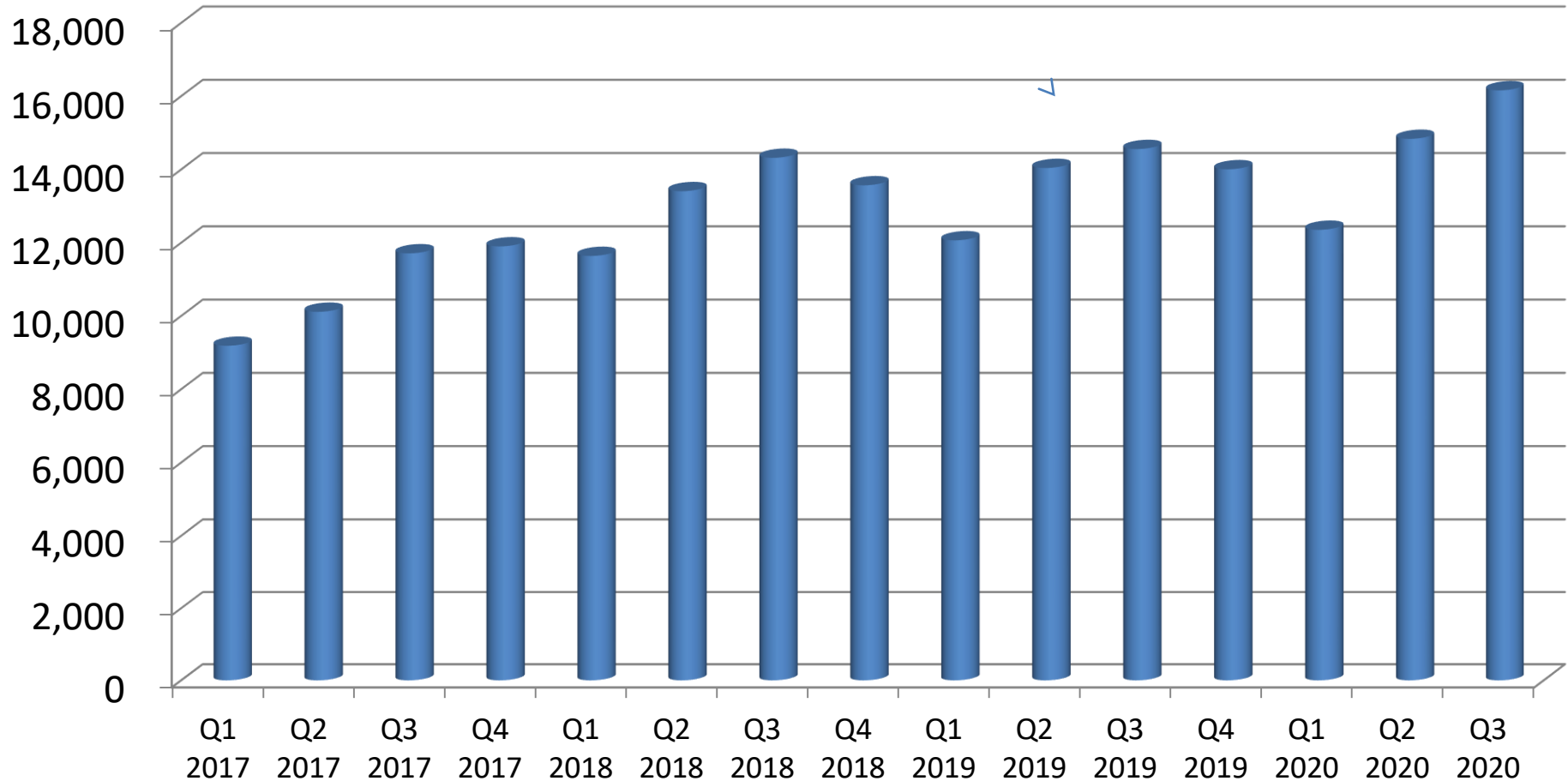

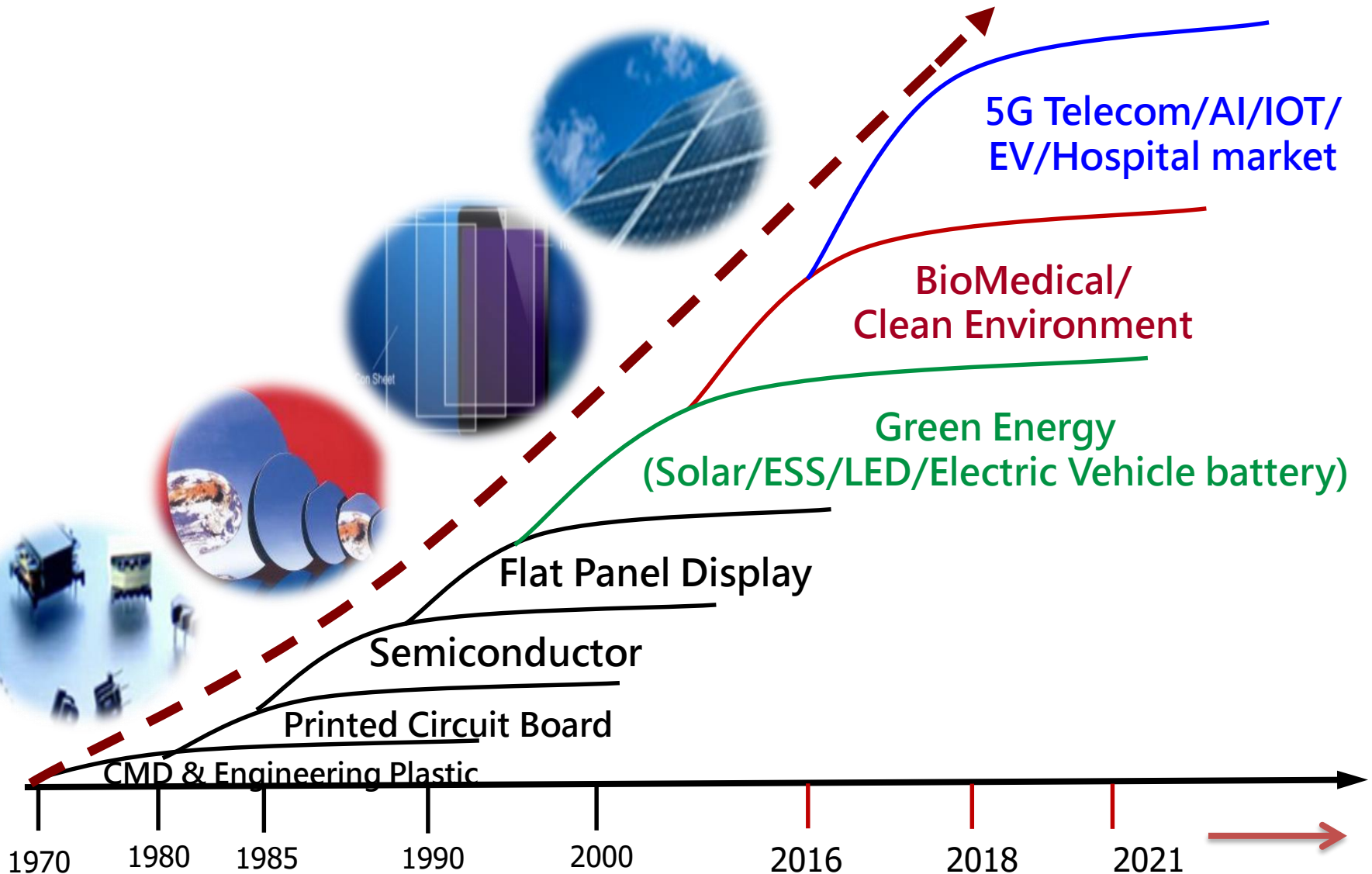

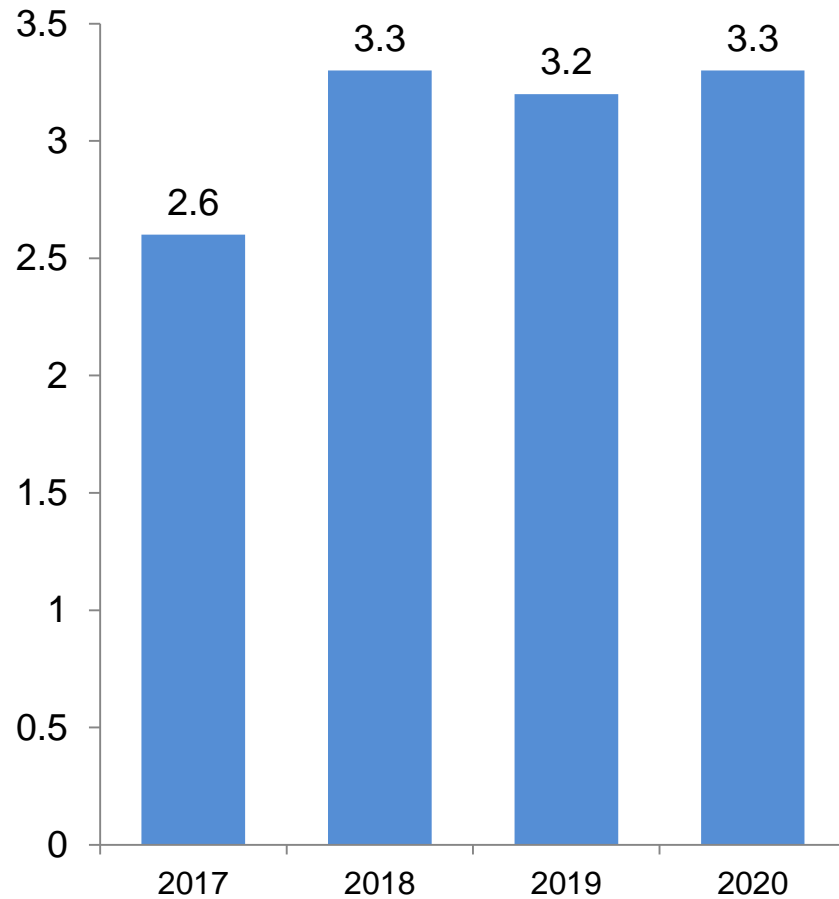

Shareholder Returns Trend 股東投資報酬

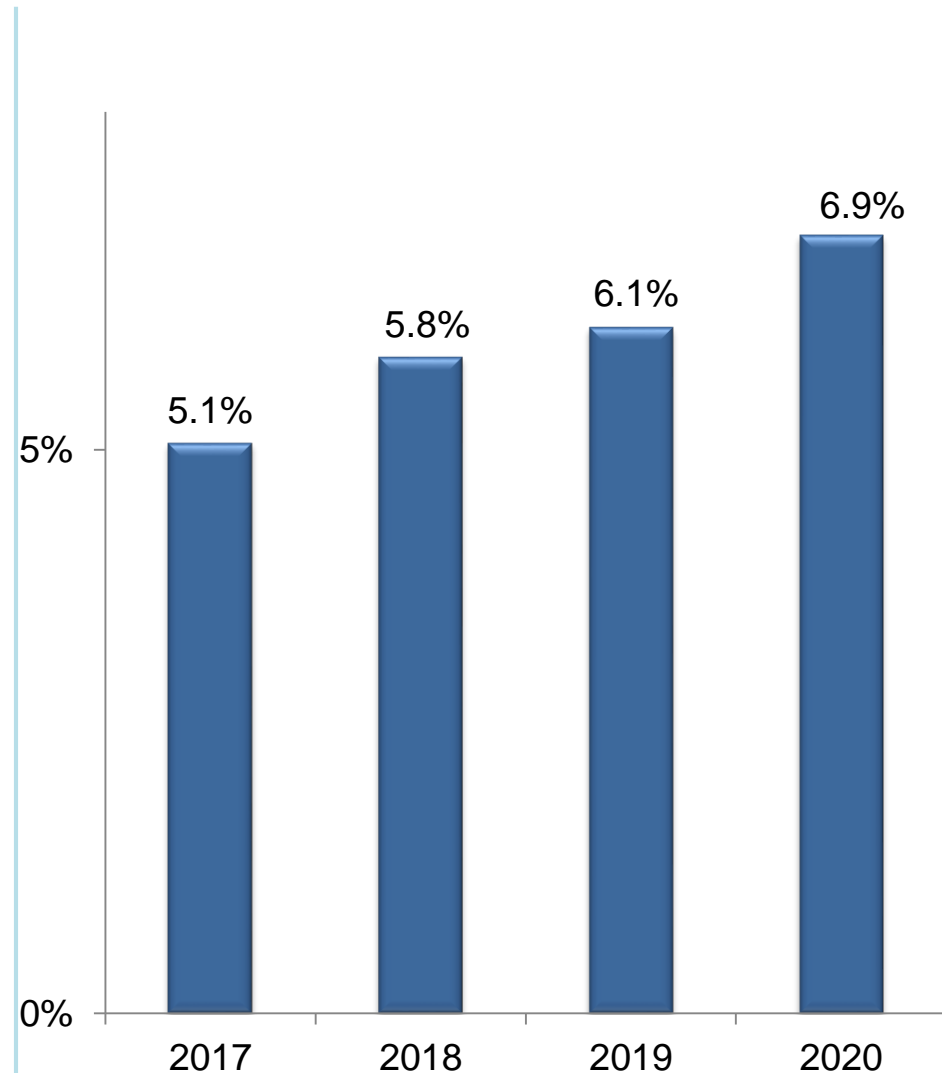
